FEE WAIVER / STUDY YEAR 2025-2026

With this form, you can apply for exemption from paying the Kokkola Art School's tuition fees for the academic year 2025–2026. A fee waiver may be granted to 10% of the number of students. Depending on the criteria, a semi-free place may also be granted. Fee exemptions are granted for one study year at a time on financial grounds. The student's activity in studies is also taken into account.

APPLICATIONS MUST INCLUDE:

1. Fee waiver application form
2. Copy of guardians' tax certificate for 2024
(Information on both guardians in joint custody and a tax certificate for both are attached; the certificate shows the person's final taxable income for municipal tax purposes.)
3. A report on other relevant factors if the family's situation has changed substantially since the previous tax year
(e.g. a decision on daily allowance or debt restructuring, a statement of the full-time studies started, etc.)

The application and its attachments must be submitted **no later than 21.9.2025**. We recommend that you fill in the application form online at <http://www.kokkola.fi/en/artschool>. Alternatively you can fill out a paper form and send it with necessary attachments via email or by mail to the Kokkola Art School's office. For applications and attachments sent by e-mail, we recommend the use of secure e-mail <https://www.securedmail.eu/message/ktk-bks@kokkola.fi?lang=en>. **Late applications will not be considered.**

Applications shall be treated confidentially. The applications and their appendices will be destroyed according to information security standards after the end of the school year for which the fee waiver applies.
